The first two weeks of July was humid with daytime highs at or above 100 degrees. Heavy rain on the night of July 4 caused flash flooding that washed out bridges and caused a major train accident between Avoca and Atlantic. Virginia's younger sister, Eunice, planned a trip to St. Louis to visit relatives and asked Virginia to go with her. Virginia makes several references revealing how badly she wants to get away for a few days, then on the 15th wrote that she "felt rather let down again." She will not be going to St. Louis. Her journal resumes.

July 16. Washed. C. to Red Oak all day. Showered along in

the am. Picked beans late this afternoon. Kids popped corn. We went to Happy Hollow with Harry and Pauline Williams. Vikings played. Jitneys came after Bill after we left.

(Happy Hollow is an area building that was used for dances, meetings, etc. "The Vikings" was a Polka band. The "Jitneys" are Claude and Millie Buss; Bill is their son.)

July 17. Not a bad day. Partly cloudy. Ironed. Baked bread and cake and canned 7 quarts of beans. Lila helped like a good fellow. C. gone in pm. Boys over to Sheridan's and Doris Hildebrand came over here. Went to see Bob Burns in "I'm from Missouri."

He was baptized into Christ when he was twelve years old at Central Church of Christ in Griswold. He graduated from Griswold High School where he enjoyed playing his saxophone in the Griswold marching band. He was somewhat

mischievous and know as the class clown. He often got into fights just for the fun of it, and to top it all off, he was voted as the happiest-golucky kid in the whole town. His big smile took him a long way.

During World War II, Bob (or Bobby, or Bubbling Bobby) worked in the Laco Oil Burner factory. He also helped build houses and worked at Gateway Iron Works in Omaha, as well as for his dad at Boseck Oil and Ford Motor Company.

They were united in marriage on August 8, 1949, and while still working for his dad, Bob was drafted into the U.S. Army in January 1952. He served in the Corps

Nachos Magnifico

1 lb ground beef 1 cup chopped onion

3/4 tsp salt

1/4 tsp pepper tortilla chips

2 (16 oz cans) refried beans 4.5 oz can diced green chilies 1 cup salsa

1 cup shredded cheddar cheese

1 cup shredded mozzarella cheese

1 cup shredded Monterey Jack cheese

12 oz container guacamole

1 1/2 cup sour cream

2 1/4 oz can sliced black olives, drained

1/2 cup chopped green



10 Doctor-Recommended Health Tips for the New Year

Adults should do at least 150 minutes a week of moderate-intensity activity, or 75 minutes a week of vigorous-intensity activity.

- 3. Visit LowerYourHBP.org to better understand blood pressure numbers and take necessary steps to get high blood pressure also known as hypertension -- under control. Doing so will reduce your risk of heart attack or stroke.
- 4. Reduce your intake of processed foods, especially those with added sodium and sugar. Eat less red meat and processed meats, and add more plant-based foods, such as olive oil, nuts and seeds to your diet. Also reduce your consumption of sugar-sweetened beverages and drink more water instead. Drinking sugary beverages -- even 100% fruit juices -- is associated with a higher all-cause mortality risk, a new study published in JAMA Network Open suggests.
- 5. If your health care professional determines that you need antibiotics, take them exactly as prescribed. Antibiotic resistance is a serious public health problem and

antibiotics will not make you feel better if you have a virus, such as a cold or flu.

- 6. If consuming alcohol, do so in moderation as defined by the U.S. Dietary Guidelines for Americans -- up to one drink daily for women and two drinks daily for men, and only by adults of legal drinking age.
- 7. Talk with your doctor about tobacco and e-cigarette use (or vaping) and how to quit. Declare your home and car smoke- and aerosol-free to eliminate second-hand exposure.
- 8. Pain medication is personal. If you're taking prescription opioids or other medications, follow your doctor's instructions. Store them safely to prevent misuse and properly dispose of any leftover medication.
- 9. Make sure your family is up-to-date on vaccines, including the annual influenza vaccine for everyone age six months or older. If you're pregnant, you can receive the flu vaccine during any trimester, but should receive the Tdap vaccine early in the third trimester to protect yourself against flu and whooping cough.
- 10. Manage stress. A good diet, sufficient sleep (at least 7.5 hours per night), daily exercise and wellness activities, like yoga and meditation, are key ingredients to maintaining and improving your mental health, but don't hesitate to ask for help from a mental health professional when you need it.



Commercial Pesticide Applicators Continuing Educations Courses



a type of horn he called the "Bazooka." The movie was playing at The Strand in Griswold.)

July 18. Quite warm. Up early. C. & Irving finished mowing the sweet clover. C. went to the lake. Boys all stayed home. Expected Busses for supper but they didn't come till late. Made ice cream. Bill stayed.

(We don't know why Clayton went to the lake by himself. The temperature was a humid 100 degrees, mowing behind horses was a sweaty job, and a lot of people went to the one-acre pool at "the lake" just to take a bath and cool off. Clayton never did. Lila recalls that he was deathly afraid of water.)

July 19. Lila cleaned upstairs. I felt so tired. C. gone again all day. Jimmie gone all afternoon. Kids all bathed. Went in to Lewis. Blew up real cool but no rain. C. brought me a malted milk. Celebrated.

(A malt at the soda fountain in Lewis's drug store was no doubt a treat, but July 19 is their wedding anniversary. Was the word "celebrated" an example the wry sarcasm she often employs? On this same day The American announced the birth of Sharon Kay Casady. The previous Sunday her father, Claude Casady, hit a bases loaded home run at the Crystal Lake diamond to give Lewis a 10-7 win over Bridge-

July 20. Cleaned pantry out in am. C. gone thrashing. Cloudy but no rain. Subscribed to a magazine for the kids and to Ladies Home Journal again. Jimmie and I did most of the chores. I picked beans again.

July 21. Canned 4 qt. of beans. Have 33 quarts now. Sewed some on dress. Irving threshed in C.'s place so he could work around here in am. He was out on the road in afternoon. Nothing but car trouble. Polly and Irving and Tommy and mom out in eve. Made ice cream. Lawn chairs we ordered came.

(Clayton was "out on the road" a lot, and he's gotten his driver's license. Readers may remember that a month earlier Virginia wrote that he "applied for a driver's license." The application was a form to completed and mailed, along with a fee, to an office in Des Moines. There was no test; anyone who made application was approved and their license mailed. An increasing number of cars were on the road and about the time Clayton got legal F.W. Hanton, editor of The American, risked the ire of Lewis merchants by publishing a front-page article that was

dian and musician who invented more editorial than news item. He noted that the current riverto-river route through this area was No. 6, although an alternate was No. 92 to 71 near Lyman, then north to Fletcher Chapel and west through Lewis to No. 6. Hanton asked area residents to support a proposal that would make No. 92 a hard-surface road from Lyman to Griswold and eventually on to Council Bluffs. This marked the continuation of a sharp disagreement Charles Wiley, editor of the Lewis Standard, had with other area editors and the Iowa Highway Commission. The White Pole Road originally passed through Lewis. When plans were made to create a paved route that would be known as No. 6, Wiley was assured that the route would pass from Atlantic through Lewis and then to Oakland. Wiley didn't know Lewis was being bypassed until construction was underway. The only crumb was that No. 92 traffic going west would still pass through Lewis. Wiley foresaw the possibility of extending 92 to Griswold, leaving Lewis high and dry. Hanton was now lobbying for just that and Wiley wasn't around to object. His health had failed and when the Depression settled in the Standard went under. Hanton bought the subscription list, and there was no longer a newspaper that put Lewis' interests first.

July 22. Got cleaning all done in am. Baked bread, 2 pies and a cake. C. threshed in am. Irving and Harry out in pm. Started threshing here about 5. Everything late. They finished at 9 o'clock and then we went to town. I had 10 people here

July 23. Nice day. Went to show in afternoon, "Dodge City." Took Lila's clothes into her and she stayed at Polly's. Mewhirters came over in eve.

("Dodge City," playing at The Strand, was a technicolor film starring Erroll Flynn and Olivia De Haviland.)

July 24. Feel so old. I didn't wash. Made peach pie and cupcakes. Thought Stamps would be here, but were not. Threshed at Hildebrands and Woodwards and Phillips. Club in the pm. Not much luck there. Washed woodwork and windows in the old kitchen.

July 25. Rained last night. No threshing today. C. gone most of day. Boys played at Fultons in am and they went with C. in pm. I did washing and cleaned the upstairs. Picked a mess of beans and cukes in eve. C. mixed up some hog wormer.

July 26. Cool in am but h-o-t

in afternoon. Ironed and made a pie. C. & Jimmie gone all day. Finished threshing. To Lewis in eve and went to the show. Eunice had some nice things for all of us. Francis came home with Lila.

(Eunice, the phone operator and younger sister, has returned from a trip to St. Louis. The outdoor temperature that day was at or near 100. Using the kitchen range to bake pie and heat the iron, without electricity for even a fan, must have made the kitchen an oven.)

July 27. C. gone all day. Glen and Alfred Stamp here for dinner. Another hot day. Baked bread and 2 apple pies. C. quit combining. No luck. Paul Smith came up in eve. Kids and I to bed in good time. Blew up cool.

July 28. Swell day. Cool all day. C. gone all day. Almost finished my dress.... One button left to sew on. Wrote to Wilma. Lila and Francis cleaned upstairs. Busses here in eve. C. and Claude Buss went to Lewis on business. Shower in the night. Picked 2 pails of cukes.

(This is Friday evening. Clayton and Claude Buss like to spend time socializing in the Lewis Pool Hall. Virginia periodically inserts a bit of sarcasm, and may have done so here in writing that they went to Lewis "on business.")

July 29. Felt outright old. Baked 2 pies and a cake C. ground feed in am.??? went into Lewis with him at noon. I canned 13 quarts of cukes in afternoon. We went to town in eve.

July 30. Went to Cables for Sunday dinner, then to the lake in the afternoon. Came home, did chores and went back to Cables and made ice cream. Kids all dead tired. Hank G. paid Jimmie.

(Hank Grulke is a farmer and thresher and Jimmie, usually riding a pony, hauls water for the crew.)

July 31. Felt old. Cold sore and stiff neck. Made Lila a pair of pajamas. Doris and Laura here to play in pm. Picked a few cukes. Paul Smith here in eve. C. gone all day.

Next month is highlighted for the Mundorfs by a rodeo and carnival in Atlantic. Featured at the rodeo was Miss Pearl Biron, "The Cowgirl William Tell," who appeared in a movie with Hoot Gibson a few years earlier. The big news, though, was a downpour that flooded Deep Creek and did major damage to the amusement park that was nearly as popular with Griswold and Atlantic residents as it was those from Lewis.
